TLC dogs are often available by appointment only; you will set up the appointments and meet potential adopters. You will be tracking dog's behavior progress while they are in the TLC program and even after adoption. You will also at times be working with cats that need behavior intervention. Ideal candidate will be dependable self-starter, with the ability to learn new duties. <u>Must have prior Animal Handling and husbandry experience</u>. **Certified in Pet Behavior Training using positive reinforcement methods is a plus.** Solid work history and ability to work a Tuesday- Saturday schedule, including weekends and holidays, required.
